FORMER LOV FUND PARTICIPANTS

To All Participants:

As the Board of Trustees, we are pleased to present you this Summary Plan Description, which is commonly referred to as the “SPD,” describing the features of the Indiana/Kentucky/Ohio Regional Council of Carpenters Pension Plan (“Plan”). This Plan is the successor plan resulting from the merger of the Lower Ohio Valley District Council Pension Trust Fund (“LOV Fund”), the Northwest Indiana Regional Council of Carpenters Pension Fund, the Kentucky State District Council of Carpenters Pension Trust Fund, and the Carpenters Local Union No. 215 Pension Fund (collectively the “Prior Plans”), which was effective July 1, 2012.

You were previously notified that your participation in the Plan after the merger described above continued under the same rules that were in effect under your Prior Plan for work that you performed through December 31, 2012. In other words, any benefits that you earned before January 1, 2013 are subject to the provisions of the Prior Plan in which you had been participating, and any benefits that you earn for work performed after December 31, 2012 are subject to the provisions of this Plan, as explained in this SPD.

This SPD summarizes some of the important features of the Plan’s administration. The information in this SPD reflects the terms of the Plan through January 2025. The provisions of this SPD only apply to you if you (i) participated in the LOV Fund prior to the merger and (ii) worked for an employer that contributed to this Plan on your behalf after the merger. If you left such employment before the merger, you should contact the Plan Office for information regarding the provisions that are applicable to you.

Your pension benefit is one of the most important aspects in your lifetime of financial planning. It is important that you read this SPD carefully. We also urge you to show this SPD to your family so that they are aware of your retirement pension and the survivor protection features. Please note that you also previously received a separate SPD for your Prior Plan. You should place this Plan’s SPD with your Prior Plan’s SPD and save them both for future reference. It is important to emphasize that any vested benefits you earned before January 1, 2013 will continue to be subject to the terms of your Prior Plan.

The Trustees will continue to keep you advised of any changes in the provisions of this Plan, as we continue our efforts to provide a greater measure of security for employees who work in the industry. However, we can only keep you advised if the Plan Office has your current address on record at all times.

If you have any questions about your pension benefits under the Plan, please contact the Plan Office; the representatives at the Plan Office will be happy to assist you.

BOARD OF TRUSTEES

Your pension rights are governed by the provisions of the Plan Document of this Plan, as amended from time to time. You may wish to refer to the full text of the Plan Document to answer specific questions. If any inconsistencies exist between the information included in this SPD and the provisions of the Plan Document, the provisions of the Plan Document will prevail. A copy of the full text of the Plan Document can be obtained by contacting the Plan Office in writing. A charge may be applied for a copy of the Plan Document. However, the Plan Document may be reviewed, without charge, at the Plan Office.

Benefits under this Plan will be paid only if the Board of Trustees decides in its discretion that the applicant is entitled to them. The Trustees have full discretion to determine the facts for each claim, and to interpret and apply all provisions of the Plan Document according to its terms.

IMPORTANT INFORMATION

Plan Merger and Transition Rules for Your Benefits

Following the merger of the Prior Plans to form this Plan, you technically could have begun participating in this Plan on July 1, 2012. However, your benefits for work you performed through December 31, 2012 continued to be determined under the same rules that were in effect under your Prior Plan (the LOV Fund). Thus, for ease of reference, this SPD's use of "LOV Fund" or "your Prior Plan" also will cover the period from July 1, 2012 through December 31, 2012 during which the LOV Fund's rules continued to apply to you under the Plan.

Starting on January 1, 2013, pension benefits ceased accruing under your Prior Plan's rules and began to accrue under the rules of this Plan. In other words, the Plan's rules relate to benefits only for years of service worked after December 31, 2012, for which Employer contributions are required to be paid to the Plan on your behalf. The information in this SPD primarily describes the pension benefits and rules applicable to those benefits that you may earn under this Plan after 2012. A separate SPD was previously provided to you that describes your Prior Plan's benefits and rules, which you should read in conjunction with this SPD. You may obtain a copy of your Prior Plan's SPD by contacting the Plan Office.

Determining Your Pension Benefits

Your Prior Plan's rules are separate from this Plan's rules, and benefits under each plan are determined separately based upon the rules of each plan and the service earned under that plan. The benefits under each plan are then combined for purposes of determining the total pension benefit provided by the Plan. Therefore, at the time you retire and become eligible for a pension, you will receive your entire pension benefit from this Plan, which will be based on both (i) your service earned before January 1, 2013, determined under your Prior Plan's rules, and (ii) any service you earn after December 31, 2012, determined under this Plan's rules.

Save this SPD

Read this SPD carefully and save it for future reference. Make certain you understand the Plan fully so you can use it to your best advantage. Tell your family, particularly your spouse, about this SPD and where you keep it filed.

Plan Documents Control

This SPD describes the benefits provided by the Plan in general terms and does not provide all the rules under which the Plan operates. If there is an inconsistency between the Summary Plan Description and the legal documents governing the operation of the Plan, such as the Plan Document, Trust Agreement, Collective Bargaining Agreements or Plan rules and regulations, those legal documents will control.

File Early

When you are planning your retirement, you should try to file your pension application with the Plan Office about six months before your retirement date. It typically takes several months to collect all of the information needed to process your application.

Changes to the Plan

The Board of Trustees reserves the right to amend, modify or discontinue all or part of the Plan whenever, in its judgment, conditions so warrant. If the information in this SPD changes, the Plan Office will send you a notice of the change in accordance with the law.

Determination by Board of Trustees Binding

Following the merger, the Board of Trustees of the Plan has complete authority to apply and interpret this SPD, the Plan Document and the Prior Plan documents, and to determine the level of proof that will be required to establish eligibility for benefits.

All questions or controversies of whatsoever character, arising in any manner or between any parties or persons in connection with this Plan, the Prior Plans or their operation, whether as to any claim for benefits, or as to the construction of language or meaning of this SPD and the Plan Document, or as to any writing, decision, instrument or accounting in connection with the operation of the Plan or Prior Plan, or otherwise, shall be submitted to the Trustees or, where Trustee responsibility has been delegated to others, to such delegates for a decision. Any decision of the Board of Trustees shall be binding upon all persons. In the event a claim for benefits is denied, no lawsuit or other action against the Plan or the Trustees may be filed until after the decision has been appealed and reviewed by the Trustees in accordance with the procedures established under the Plan.

No Agent May Interpret

The Board of Trustees of the Plan has retained a third party administrator, BeneSys, Inc. (“BeneSys”), to assist the Trustees in administering the Plan and to address your pension benefit questions under the Plan. Contact information for BeneSys (commonly referred to as the “Plan Office”) is set forth below.

You should remember that only the Board of Trustees has authority to interpret the Plan. Neither BeneSys nor Employer or Union representatives are authorized to interpret the Plan, its benefit provisions or its eligibility requirements. As a courtesy to you, members of the administrative staff at BeneSys may respond informally to telephone or in-person inquiries about your benefits. However, you should not rely on such oral information or answers because they are not binding on the Plan. Only the Board of Trustees has the discretion to determine eligibility for benefits and to interpret the Plan.

Safeguarding Plan Information and Assets

The Plan Office and other service providers, where applicable and appropriate, have put in place various privacy, security and anti-fraud measures to safeguard your confidential information and the Plan’s assets. However, you are also responsible for taking reasonable measures to keep your information secure.

FORMER LOV FUND PARTICIPANTS

Your personal information (which includes your name, date of birth, Social Security number and bank account or other financial information), account login information (user IDs, passwords, PINs, security questions, etc.) and contact information (mailing address, phone number and email address) are valuable to criminals who would want to impersonate you or steal from you. The following are some of the steps you could take to help protect your identity and financial security:

1. Register, set up and check your online accounts frequently. Activate any enhanced security features such as multi-factor authentication and automatic account lock, if available.
2. Use strong and unique passwords. Do not share, repeat or reuse passwords. Change passwords frequently or after a security breach.
3. Keep your personal and beneficiary contact information (name, mailing address, phone number and email address) current with the Plan Office. Notify the Plan Office as soon as possible after you change jobs or retire.
4. Immediately report any unusual activity or suspicious retirement transactions to the Plan Office.
5. Safeguard your personal information and beware of fraudsters and scammers. If you discover or suspect your personal information (such as your Social Security number) has been exposed or if you have been the victim of financial fraud, identity theft or a security breach that could affect your retirement benefits, please notify the Plan Office immediately.
6. Consider shredding or otherwise securely disposing of all documents containing sensitive information.
7. Practice safe computing habits, such as accessing your accounts through secure, private network connections only, sending sensitive data using secure means, turning on your firewall and keeping your antivirus and other software up to date.
8. Carefully review and follow security requirements and recommendations in notices and alerts you receive from the Plan or other service providers.

DEFINITIONS

The following abbreviated definitions of terms used in the Plan Document may be helpful in understanding the benefits which are provided and your rights under the Plan.

BENEFIT ACCRUAL CREDIT

Benefit Accrual Credit is used to determine the amount of your pension benefit that you earn under the Plan after December 31, 2012.

COLLECTIVE BARGAINING AGREEMENT

A Collective Bargaining Agreement is a written agreement that provides for an Employer's contributions to this Plan on behalf of its Employees.

COVERED EMPLOYMENT

If you work for an Employer who is required to contribute to the Plan for the hours you work in a job covered by a Collective Bargaining Agreement or other written agreement requiring contributions to the Plan, you are considered to be working in Covered Employment.

For periods prior to January 1, 2013, Covered Employment means employment that was recognized by a Prior Plan for purposes of granting credit for benefit eligibility under that Prior Plan.

ELIGIBILITY SERVICE

Eligibility Service determines your entitlement (i.e., your “Vested” right) to a retirement benefit.

ELIGIBLE SPOUSE

Your Eligible Spouse means the person to whom you were married continuously for at least a one-year period ending on the earlier of (i) the date your pension payments are to begin, or (ii) the date of your death.

EMPLOYEE

If you work for an Employer who is required to pay contributions to the Plan for hours you work on a job in accordance with a Collective Bargaining Agreement or other written agreement providing for such contributions, you are an Employee covered under the Plan.

EMPLOYER

If the employer you work for is required to contribute to the Plan in accordance with a Collective Bargaining Agreement or other written agreement providing for such contributions, it is considered an Employer under the Plan.

ERISA

The Employee Retirement Income Security Act of 1974, as amended from time to time.

HOURS OF SERVICE

An Hour of Service generally means each hour for which you are entitled to be paid by your Employer (whether for work or for other non-working time, such as vacation, jury duty or other leaves of absence from work).

NORMAL RETIREMENT DATE

For any benefits that you may earn after December 31, 2012 under this Plan, your Normal Retirement Date is the later of the date you attain age 65 or have earned at least five Years of Eligibility Service. To determine whether you have earned five Years of Eligibility Service, any Years of Eligibility Service that you earned before 2013 under your Prior Plan will be added to any Years of Eligibility Service that you may earn after 2012 under this Plan.

For any benefits you may have earned before January 1, 2013, your Prior Plan’s rules will determine your applicable Normal Retirement Date. It is important to emphasize that your Prior Plan’s Normal Retirement Date will continue to apply to any benefits that you earned before 2013.

FORMER LOV FUND PARTICIPANTS

PARTICIPANT

An Employee of an Employer who meets the requirements for participation under the Plan, as described in this SPD.

PLAN YEAR

Effective July 1, 2012, the Plan Year for this Plan is the consecutive 12-month period beginning July 1 and ending the following June 30 for each year.

PRIOR PLAN / LOV FUND

When reference is made to your Prior Plan it means the Lower Ohio Valley District Council Pension Trust Fund ("LOV Fund"). Effective July 1, 2012, the LOV Fund merged with the Northwest Indiana Regional Council of Carpenters Pension Fund, the Kentucky State District Council of Carpenters Pension Trust Fund and the Carpenters Local Union No. 215 Pension Fund. Although you technically may have begun participating in this Plan on July 1, 2012, the Plan continued the LOV Fund's rules through December 31, 2012. Thus, for ease of reference, this SPD's use of "LOV Fund" or "your Prior Plan" will include periods prior to January 1, 2013, including the period from July 1, 2012 through December 31, 2012 during which the LOV Fund's rules continued to apply to you.

UNION

Any reference to the Union means the Central Midwest Regional Council of Carpenters (previously known as the Indiana/Kentucky/Ohio Regional Council of Carpenters) and its affiliated local unions, as well as any other labor organization that becomes a party to the Trust Agreement in the manner provided in the Plan Document.

VESTED

You will be Vested with a non-forfeitable right to receive a pension if you have at least five Years of Eligibility Service or if you terminate Covered Employment on or after your Normal Retirement Date. For this purpose, Years of Eligibility Service earned both before January 1, 2013 and after December 31, 2012 will be added together to determine whether you have become Vested in the pension benefit you had earned under both (i) your Prior Plan before 2013 and (ii) this Plan after 2012.

YEARS OF BENEFIT ACCRUAL CREDIT

Years of Benefit Accrual Credit are used to determine the amount of your benefits earned under the Plan after December 31, 2012. As described in this SPD, you earn a Year of Benefit Accrual Credit under this Plan for each calendar year after 2012 in which you work in Covered Employment and earn at least 125 Hours of Service for which a contribution is required to be made to the Plan. This SPD also provides certain Transition Rules relating to the calculation of your Years of Benefit Accrual Credit for the period October 1, 2012 through December 31, 2012 (based on LOV Fund rules).

YEARS OF ELIGIBILITY SERVICE

Years of Eligibility Service are the years you have worked in order to qualify for vesting. As described in this SPD, for benefits earned after December 31, 2012 under this Plan, you earn a full Year of Eligibility Service (for purposes of the 5-year vesting rule) for each calendar year in which you earn at least one Hour of Service. These rules only apply if you accrued a benefit related to service you earned before

January 1, 2013 with an employer participating in the LOV Fund (or which would have been participating in the LOV Fund absent the merger). This SPD also provides certain Transition Rules relating to the calculation of your Eligibility Service (for vesting purposes) for the period October 1, 2012 through September 30, 2013 (based on LOV Fund rules). Please note that different rules apply to determine whether you have earned 30 Years of Eligibility Service in order to qualify for the Thirty Year Early Pension for benefits that you earn after 2012 under this Plan; these rules are described further below.

ABOUT THIS PLAN

What is the Plan?

The Plan is a pension plan established under Federal law that is funded by a tax-exempt trust fund set up for the purpose of providing retirement benefits to eligible participants and beneficiaries. The Plan's trust fund and benefit program were established by a legal document called an Agreement and Declaration of Trust. The Trust Agreement and the Plan Document together govern the Plan's operation.

What is the Plan Document?

The Plan Document is the legal document that sets forth the various types of benefits provided by the Plan, the amounts of such benefits and the eligibility requirements.

Who administers the Plan?

The Board of Trustees, which serves without any compensation, acts on behalf of you and your fellow Employees in managing all aspects of the Plan's operations. The Board of Trustees is made up of an equal number of Union and Employer representatives whose powers and duties are set forth in the Agreement and Declaration of Trust. The Trustees have retained an administrative firm to oversee the day-to-day operations of the Plan and staff the Plan Office. You can also contact the Trustees through the Plan Office.

Who pays the cost of the Plan?

The entire cost of the Plan is paid by the participating Employers who contribute to the Plan in accordance with their Collective Bargaining Agreements or other written agreements. No contributions are required from you, and none are permitted.

Who is covered by the Plan?

The Plan covers all Employees for whom Employer contributions are required to be paid into the Plan pursuant to a Collective Bargaining Agreement or other written agreement.

ABOUT PARTICIPATION

How do I become a Participant under the Plan?

If (i) you were a Participant under your Prior Plan as of December 31, 2012; (ii) a contribution was required to be made on your behalf to the Plan by an Employer on or after January 1, 2013; and (iii) you had not experienced a Permanent Break in Service, then you were automatically a Participant under the

FORMER LOV FUND PARTICIPANTS

Plan as of January 1, 2013. A separate SPD was previously provided to you that describes your Prior Plan's rules, including break in service rules, which you should read in conjunction with this SPD.

If you were hired prior to January 1, 2013, but you were not a Participant under the rules of your Prior Plan on December 31, 2012, then you become a Participant under this Plan on the first day of the month following the earlier of the date (i) that a contribution was required to be made to the Plan on your behalf, or (ii) that you are at least age 21 and have completed at least 500 Hours of Service in any 12-month period, provided that you are an Employee as of that date.

When am I no longer a Participant under the Plan?

If you have not met the requirements for vesting and you do not complete 250 or more Hours of Service in any calendar year after December 31, 2012 (*i.e.*, you experience a "One Year Break in Service" as defined below), you are no longer a Participant in the Plan. Once you have met the vesting requirements under the Plan, however, you always remain a Participant.

Can I become a Participant again after I experience a Break in Service?

Yes. You will be a Participant again if you complete 500 or more Hours of Service within a calendar year.

ABOUT YEARS OF BENEFIT ACCRUAL CREDIT AND ELIGIBILITY SERVICE

How are Years of Benefit Accrual Credit determined?

For benefits earned after December 31, 2012 under the Plan, you earn Benefit Accrual Credit for each calendar year in which you work in a contributory position and earn at least 125 Hours of Service for which an Employer is required to contribute to the Plan. The amount of your Benefit Accrual Credit will depend on the hours of contributory employment that you earn in the calendar year.

Transition Rule. Prior to January 1, 2013, your Benefit Accrual Credit was computed under your Prior Plan during each plan year (October 1 to September 30). Effective January 1, 2013, the period for computing Benefit Accrual Credit for your Covered Employment after 2012 under this Plan is the calendar year (January 1 to December 31). For your employment from October 1, 2012 to December 31, 2012, you will be credited with a "year of service" under the rules of your Prior Plan if you earned at least one hour of service during that period. A separate SPD was previously provided to you that describes the year of service rules under your Prior Plan. If you have any questions regarding your benefit, please contact the Plan Office for additional information.

How are Years of Eligibility Service determined?

Eligibility Service is important because, in general, you must have at least five Years of Eligibility Service to become Vested in your pension benefit. For your Covered Employment after December 31, 2012, you earn Eligibility Service under the Plan (for purposes of the 5-year vesting rule) for each calendar year after 2012 in which you earn at least one Hour of Service. These rules apply only if you accrued a benefit related to service you earned before January 1, 2013 with an employer participating in the LOV Fund (or which would have been participating in the LOV Fund absent the merger). If these rules do not apply to you, please contact the Plan Office for more information.

FORMER LOV FUND PARTICIPANTS

Please note that different rules apply to determine whether you have earned 30 Years of Eligibility Service in order to qualify for the Thirty Year Early Pension benefits that you earn after 2012 under this Plan, which are described further below.

Transition Rule. Prior to January 1, 2013, your Eligibility Service was computed under your Prior Plan during each plan year (October 1 to September 30). Effective January 1, 2013, the period for computing Eligibility Service under this Plan is the calendar year (January 1 to December 31). You will be credited with at least as much Eligibility Service as you would have had under your Prior Plan as if its rules applied until December 31, 2013. The LOV Fund granted a full Year of Eligibility Service if you earned at least one Hour of Service during its October 1 - September 30 plan years. Thus, if you earned one hour of service from October 1, 2012 to September 30, 2013, and if you also earned at least one hour of service from January 1, 2013 to December 31, 2013, you will receive two full Years of Eligibility Service (for vesting purposes) for the period from October 1, 2012 to December 31, 2013.

For calendar years beginning after December 31, 2013, (i) only the Eligibility Service rules under this Plan will apply to your participation, and (ii) you may only earn up to one Year of Eligibility Service for vesting purposes for any given calendar year.

If you work outside the Plan's jurisdiction with an employer who contributes to a comparable pension fund that is signatory to the UBCJA International Reciprocal Agreement or another reciprocal agreement to which the Plan is signatory, or if your employer contributes to the United Brotherhood of Carpenters Pension Fund, you may be entitled to receive Eligibility Service credit from the Plan for that service. Contact the Plan Office immediately for further information.

ABOUT BREAKS IN SERVICE

What is a Break in Service?

The Plan is designed to provide retirement benefits to Participants who have many years of work covered by the Plan. If you are absent from Covered Employment for an extended period before becoming Vested (as defined above and further described later in this SPD), your Years of Benefit Accrual Credit and Eligibility Service may be cancelled for the period before this absence. These absences are called Breaks in Service, and there are two different types:

- One Year Break in Service; and
- Permanent Break in Service.

For this purpose, a Permanent Break in Service generally would occur if you are not Vested and incur five consecutive One Year Breaks in Service. A One Year Break in Service means a calendar year after 2012 in which you fail to complete at least 250 Hours of Service.

What happens if I have a Permanent Break in Service?

In general, if you have a Permanent Break in Service as described above, you lose your status as a Participant under the Plan and any Years of Benefit Accrual Credit and Eligibility Service that you earned prior to the Permanent Break in Service are canceled. After you are Vested, however, you cannot have a Permanent Break in Service or lose your pension rights.

FORMER LOV FUND PARTICIPANTS

EXAMPLE: In the example below, assume that Carla, an Employee, is not Vested, earned two Years of Eligibility Service (Years 1-2) and then had five consecutive One Year Breaks in Service (Years 3-7). Under these facts, Carla would have a Permanent Break in Service at the end of Year 7, which would cancel all of the Years of Benefit Accrual Credit and Eligibility Service that she earned before the Permanent Break in Service.

Are there any exceptions to the Break in Service rules?

Yes. Certain periods of time may not be counted in determining if a One Year Break in Service has occurred. These periods of time will be considered exceptions if your failure to earn Years of Eligibility Service was caused by:

- Service in the “uniformed services,” as defined in the Uniformed Services Employment and Reemployment Rights Act of 1994 (“USERRA”), if the Participant has fulfilled all notice, documentation, reemployment and other provisions of USERRA;
- Absence from service because of pregnancy or an adoption of a child, or because of caring for the child for the period immediately following the birth or adoption. Under these circumstances you will be granted up to 251 hours in a calendar year to avoid a One Year Break in Service. The hours will apply in the calendar year in which the absence begins, if necessary, to avoid a One Year Break in Service or, if not required in that year, in the immediately following year. The hours will not count for purposes of earning Years of Eligibility Service or Benefit Accrual Credit; or
- The period that is considered a leave of absence under the Family Medical Leave Act (“FMLA”).

You should notify the Plan Office as soon as possible about any periods of time during which you were away from work due to military service, pregnancy, adoption or the birth of a child.

ABOUT VESTING

What is Vesting?

Vesting is the term used for earning a non-forfeitable right to a pension benefit. To be Vested, you must have earned a total of at least five Years of Eligibility Service or terminate Covered Employment on or after your Normal Retirement Date. For these purposes, any Years of Eligibility Service that you earned both before 2013 under your Prior Plan and after 2012 under this Plan will be added together to

determine whether you have a total of five Years of Eligibility Service. A separate SPD was previously provided to you that describes the Eligibility Service rules under your Prior Plan.

If I leave Covered Employment after meeting the requirements for Vesting, do I lose my right to a pension?

No. If you have met the vesting requirements under this Plan and you are considered Vested, you will have a right to a pension even if you never work again as a carpenter within the jurisdiction of the Plan.

ABOUT MILITARY SERVICE

How is military service treated under the Plan?

If you stop working in Covered Employment to enter military service, you will receive Eligibility Service and Benefit Accrual Credit during that period in accordance with federal law. Specifically, USERRA provides reemployment rights and benefits and protection from discrimination to individuals who performed voluntary or involuntary military service in any branch of the uniformed services of the United States. If you satisfy the conditions for protection under USERRA, your period of military service will be treated as Hours of Service for all purposes under the Plan, including eligibility, vesting and Benefit Accrual Credit.

Generally, to be entitled to reemployment rights and pension benefits under USERRA, you must:

- Be absent from Covered Employment because of your military service;
- Give advance notice of your military service to your Employer, unless notice is prevented by military necessity or it is otherwise impossible or unreasonable to give under the circumstances;
- Be absent due to military service for five years or less, unless extended service is required as part of your initial period of obligation or your service is involuntarily extended, such as during a war;
- Receive an honorable discharge or satisfactorily complete military service; and
- Re-apply for a job in Covered Employment within the required time period, as explained below.

For periods of military service:

- Of less than 31 days or an absence due to a fitness exam, you must report back to Covered Employment no later than the first regularly scheduled work period on the first day, after an eight-hour break, and after time for travel back home;
- From 31 days to 180 days, you must reapply for employment within 14 days after military service; or
- Over 180 days, you must reapply within 90 days after completion of military service.

These limits may be extended under the law in particular circumstances.

What happens upon my death or permanent disability while in military service?

On or after January 1, 2007, if you are unavailable for reemployment at the times prescribed by USERRA above due to death or Total and Permanent Disability while in military service, the Plan will treat your service as if you were reemployed on the day before your death or disability and then were terminated on the date of your death or disability. This means that you will receive Hours of Service and Benefit Accrual Credit for the period of your military service, in accordance with law.

ABOUT PENSION BENEFITS

What types of pension benefits are provided by the Plan?

This Plan provides several types of pension benefits for any Benefit Accrual Credit that you earn after December 31, 2012, including a Normal Pension, an Early Pension and a Thirty Year Early Pension. This Plan also provides a Disability Pension for benefits that you may have earned both before January 1, 2013 under your Prior Plan and after December 31, 2012 under this Plan. These pensions are described below.

IMPORTANT: Please remember when planning your retirement that you generally must stop working before you may start receiving your pension benefit from the Plan. You also must complete an application and submit it to the Plan Office to begin receiving your pension benefit. Please review this SPD for more information on applying for your pension benefit. Payment of your pension benefit cannot begin earlier than the first day of the month after the Plan Office receives your pension application.

Normal Pension. For any benefits that you earn after December 31, 2012 under this Plan, you qualify for an unreduced Normal Pension when you reach your Normal Retirement Date, which is when:

- You are at least age 65; and
- You have earned at least 5 Years of Eligibility Service. To determine whether you have 5 Years of Eligibility Service, any Years of Eligibility Service that you earned before 2013 under your Prior Plan will be added to Years of Eligibility Service that you may earn after 2012 under this Plan.

Early Pension. For any benefits that you earn after December 31, 2012 under this Plan, you qualify for a reduced Early Pension when:

- You are at least age 55; and
- You have earned at least 5 Years (but less than 30 Years) of Eligibility Service. To determine whether you have 5 Years of Eligibility Service, any Years of Eligibility Service that you earned before 2013 under your Prior Plan will be added to Years of Eligibility Service that you may earn after 2012 under this Plan.

Thirty Year Early Pension. For any benefits that you earn after December 31, 2012 under this Plan, you qualify for a Thirty Year Early Pension when you have earned at least 30 Years of Eligibility Service regardless of your age. Your Thirty Year Early Pension will be reduced if you begin receiving payments before you are at least age 55. To determine whether you have 30 Years of Eligibility Service, any Years

of Eligibility Service that you earned before 2013 under your Prior Plan will be added to Years of Eligibility Service that you may earn after 2012 under this Plan.

With respect to the portion of your benefits earned after 2012 under this Plan, and solely for purposes of determining whether you have earned 30 Years of Eligibility Service in order to qualify for these Thirty Year Early Pension benefits under the Plan, you earn Years of Eligibility Service after 2012 for each calendar year according to the following schedule:

<u>Hours of Service</u>	<u>Years of Eligibility Service</u>
125 - 249 Hours	0.25 years
250 - 374 Hours	0.50 years
375 - 499 Hours	0.75 years
500 or more Hours	1.00 years

How does the Plan coordinate benefits with my Prior Plan?

At the time you retire and become eligible for a pension under your Prior Plan and/or this Plan, you will receive your monthly benefit payments from this Plan. Your total monthly benefit payment will be based on the benefit that you earned before January 1, 2013 under your Prior Plan, plus any benefit you earn after December 31, 2012 under the terms of this Plan.

The calculation of your pension benefit under this Plan and your Prior Plan is complex. This SPD does not explain all the rules that may apply to the calculation of your pension benefit under the Plan. If you have questions about the coordination of your benefits under this Plan and your Prior Plan, please contact the Plan Office. Additionally, a separate SPD was also previously provided to you that describes the pension benefit rules under your Prior Plan for benefits that you earned before January 1, 2013. Please note that this Plan does NOT affect the benefits you earned under your Prior Plan before 2013; such benefits are protected by law.

What is the amount of the Normal Pension benefit?

For your Covered Employment after December 31, 2012, you will earn a pension benefit under the Plan for each calendar year in which you earn Benefit Accrual Credit, *i.e.*, a calendar year in which you earn at least 125 Hours of Service for which an Employer is required to contribute to the Plan. The amount of the benefit that you earn for each calendar year after 2012 in which you earn at least 125 hours of contributory service will equal a percentage of the total amount of contributions required to be made to the Plan on your behalf for that year. Your applicable benefit accrual percentage depends on whether your Employer was required to make contributions to the Plan on your behalf for more than \$7.00 per hour. Your monthly benefit, payable at your Normal Retirement Date, for a Year of Benefit Accrual Credit that you earn after 2012 is based on the following percentages:

- 1.2% of the first \$7.00 of hourly contributions for each calendar year; plus
- 1.6% of the hourly contributions for each calendar year that were above \$7.00 per hour.

EXAMPLE: Jim earns at least 125 Hours of Service for each calendar year from January 1, 2013 until he retires on December 31, 2022. Jim then begins to draw his pension on January 1, 2023 at age 65. For each calendar year during that 10-year period, Jim had hourly contributions required to be made on his behalf to the Plan of \$5.50 per hour for 1,500 hours. Under the new percentage of contribution formula above, the amount of Jim's monthly pension benefit earned under the Plan for each calendar year 2013 through 2022 would be calculated as follows:

IMPORTANT: As illustrated in the above table, the amount of the Normal Pension under the Plan depends on the hourly contribution rate and total amount of annual contributions required to be made to the Plan on behalf of Participants after 2012. For the sake of simplicity, the above example assumes an equal hourly contribution rate and contribution amount for each calendar year from 2013 to 2022. An Employer's actual annual contribution rate and contribution amount, however, may change from year to year or from Collective Bargaining Agreement to Collective Bargaining Agreement. Your Employer's contribution requirements are specified in the applicable Collective Bargaining Agreement.

FURTHER IMPORTANT: Please remember that a variety of factors can affect the amount of your monthly pension benefit. For example, the amount of your monthly pension benefit is affected if you begin receiving your benefit before your Normal Retirement Date, if you have earned less than 30 Years of Eligibility Service and/or if you receive your benefit in a form other than a Single Life Pension (described below).

What is the amount of the Early Pension benefit?

To determine the amount of your Early Pension for any benefits that you earn after December 31, 2012 under the Plan, the amount of your Normal Pension will first be calculated and then reduced by $\frac{1}{2}$ of 1% for each month (6% per year) that your reduced Early Pension begins before you attain age 65 (which is your Normal Retirement Date for benefits earned after 2012).

EXAMPLE: Joe was hired in 1998, attains age 60 in 2022, and earned more than 5 years (but less than 30 years) of Eligibility Service. Joe earned a Normal Pension benefit of \$1,000 per month for his service under the Plan after 2012 (based on 10 Years of Benefit Accrual Credit and contributions from 2013-2022). If Joe begins to receive his Early Pension at age 60, he will receive a monthly benefit of \$700 (a 30% reduction at age 60, based on his pension beginning 5 years before age 65 and

at a reduction of 6% per year). This monthly pension would be added to any monthly pension that Joe earned before 2013, and his pre-2013 benefit would be reduced in accordance with his Prior Plan's rules.

The calculation of the reduced Early Pension benefit under your Prior Plan will remain in effect for benefits that you may have earned before January 1, 2013.

What is the amount of the Thirty Year Early Pension benefit?

For any benefits that you earn after December 31, 2012 under the Plan, the amount of your Thirty Year Early Pension depends on whether you begin receiving payments before attaining age 55.

Commence payments on or after age 55. If you have earned at least a total of 30 Years of Eligibility Service and begin receiving payments after attaining age 55, your Thirty Year Early Pension will be the full amount of your Normal Pension.

Commence payments before age 55. If you have earned at least a total of 30 Years of Eligibility Service, you may elect to begin receiving your pension before you reach age 55. However, your pension will be reduced by $\frac{1}{2}$ of 1% for each month (6% per year) that your pension begins before age 55.

What happens if I receive an overpayment of my pension benefit?

The Plan has the right to recover amounts paid to or on behalf of any individual who was not entitled to such payment through appropriate legal or equitable action, including, but not limited to, the initiation of a collection action under ERISA or applicable federal or state law, the imposition of a constructive trust or the filing of a claim for equitable lien. The Plan has the right to reduce future payments due to such individual, including to the individual's spouse or other beneficiary. The Plan is entitled to recover the principal amount of the overpayment plus interest at a rate determined by the Trustees and all costs of collection. Any pursuit of overpayment recovery will be made in a manner consistent with applicable law, including the SECURE 2.0 Act of 2022.

ABOUT DISABILITY PENSION BENEFITS

Are benefit payments available to Participants who are unable to work because of disability?

Yes. For applications received after December 31, 2012 for any benefits that were earned both before January 1, 2013 under a Prior Plan and after December 31, 2012 under this Plan, a Participant qualifies for a Disability Pension if he or she:

- First files an application for a Disability Pension with the Plan Office after December 31, 2012;
- Experiences a "Total and Permanent Disability" (as defined below);
- Earned at least 5 Years of Eligibility Service (including Years of Eligibility Service earned before 2013 under a Prior Plan);
- Earned at least 125 Hours of Service during at least 1 of the 8 calendar quarters immediately preceding the quarter in which the Participant experiences the Total and Permanent Disability (including Hours of Service earned during calendar quarters before 2013 under a Prior Plan); and

- Earned at least 125 Hours of Service during 10 of the 20 calendar quarters immediately preceding the quarter in which the Participant experiences the Total and Permanent Disability (including Hours of Service earned during calendar quarters before 2013 under a Prior Plan).

For these purposes, a Participant will be deemed to have a “Total and Permanent Disability” either upon a finding by the Social Security Administration (or a determination by the medical consultant retained by the Trustees) that the Participant is (or, in the case of determinations made by the medical consultant, should be) entitled to total disability benefits under the Social Security Act. A Participant must provide evidence that he or she has applied to the Social Security Administration for a disability benefit before the application for Total and Permanent Disability Pension is submitted to the Plan’s medical consultant. In addition, the Participant’s treating physician must corroborate that the Participant has a Total and Permanent Disability.

There is an exception for Participants who experience a gap between their termination of Covered Employment and the date of their Total and Permanent Disability. To qualify for this exception, you should advise the Plan Office if you (a) experienced a Total and Permanent Disability, (b) terminated Covered Employment due to the health condition that disabled you from engaging in gainful employment, (c) met the requirements above when you terminated Covered Employment and (d) have not engaged in gainful employment since you terminated Covered Employment.

What is the amount of the Disability Pension benefit and when do payments begin?

For Disability Pension applications received after December 31, 2012, the following applies to Disability Pensions for benefits earned both before January 1, 2013 under your Prior Plan and after December 31, 2012 under this Plan.

The amount of the Disability Pension is the same as your Normal Pension and is paid in the form of a Single Life Pension. If the Trustees determine that you are eligible for a Disability Pension, you will begin receiving payments effective as of the first day of the month following the later of (i) the onset of your Total and Permanent Disability, or (ii) the date you file a written application for a Disability Pension with the Plan Office.

Unless you are eligible for another type of pension under the Plan, your Disability Pension payments will be terminated if you maintain or obtain any occupation or employment for which you are paid and which is inconsistent with the Trustees’ determination of Total and Permanent Disability. Disability Pension payments will stop also if the Trustees find, on the basis of medical evidence, that you have recovered sufficiently to resume work in a regular occupation or employment for which you would be paid.

The Trustees have the right to request that you undergo a medical examination while receiving Disability Pension payments. If you refuse to undergo a medical examination, Disability Pension payments will be stopped until you have the examination and the Trustees determine from such examination that you continue to be Totally and Permanently Disabled.

If your Disability Pension begins before you become eligible for an Early Pension, your Disability Pension will terminate when you reach your Normal Retirement Date. At that time, you must complete an application and submit it to the Plan Office to begin receiving your Normal Pension, which may be paid in any payment form permitted under the Plan (subject to spousal consent, if married). The Plan Office will provide more information about your payment options, including when spousal consent is required.

If your Disability Pension begins on or after the day you reach your earliest retirement age, your Disability Pension will continue to be paid in the form of a Single Life Pension; you will not be provided an opportunity to elect a different payment form later, even if your Disability Pension is terminated for reasons described above. If married, your spouse must consent to your election to begin receiving a Disability Pension prior to your earliest retirement age. If you desire to receive your benefit in a form other than a Single Life Pension, you can elect an Early Pension.

ABOUT RECIPROCAL AGREEMENTS

What is a reciprocal agreement?

If, because of job changes or transfers, you have worked under the jurisdictions of several different plans, you may not qualify for any pension under any such plan if you do not have sufficient service under the jurisdiction of any one plan. To remedy this, plans sometimes enter into agreements known as reciprocal agreements to transfer contributions and service hours to a Participant's "home fund."

Because the rules regarding reciprocity are complex, please contact the Plan Office if you would like more detailed information about the Plan benefits under a reciprocal agreement.

How do I know if work is covered by a reciprocal agreement?

The Plan maintains more than one reciprocal agreement. If you have worked in another territory under the jurisdiction of a collective bargaining agreement or should you move to another jurisdiction, immediately call or write the Plan Office for information pertaining to this feature of the Plan.

ABOUT FORMS OF PAYMENT OF PENSION BENEFITS

What is the standard form of payment for married and unmarried Participants?

Your "standard form of payment" is the payment form automatically applicable to your pension benefit (unless you elect a Disability Pension, which is paid in the form of Single Life Pension, as discussed above). Your standard form of payment depends on whether you have an Eligible Spouse at the time your pension benefit first becomes payable.

- If you do **not** have an Eligible Spouse at the time your pension benefit becomes payable, your standard form of payment is a Single Life Pension.
- If you do have an Eligible Spouse at the time your pension benefit becomes payable, your standard form of payment is a 50% Qualified and Joint Survivor Annuity.

You automatically will receive payment in the applicable standard form described above unless you reject it in writing during the designated period before payments start and select another form of payment. You may not reject a 50% Qualified and Joint Survivor Annuity (or another Qualified and Joint Survivor Annuity option, as described below) unless your Eligible Spouse consents. Your Eligible Spouse's consent must be in writing and notarized or witnessed by a Plan representative. When you become eligible for a distribution, the Plan Office will provide more information about your payment options, including when spousal consent is required.

What are the optional forms of benefit payment permitted under this Plan?

In addition to the standard forms, the Plan has several other forms of payment that may be available for pension benefits that you earn under the Plan on or after January 1, 2013. As indicated above, the Qualified and Joint Survivor Annuity options may only be elected if you have an Eligible Spouse at the time your pension benefit becomes payable. Also as described above, if you are married, you only may elect certain options if your Eligible Spouse consents to those elections in writing.

These benefit options provide you with an actuarially adjusted benefit that generally will be paid to you as a monthly benefit over your lifetime. In addition, you may be eligible to receive your pension benefit in a form that provides continuing payments to your surviving Eligible Spouse or another beneficiary after your death. At the time you retire, you will receive information explaining the types of benefits and the amount you would receive under each type in more detail. The right form of payment for you depends on your individual situation. You may wish to consult a financial planner when considering your options.

- Single Life Pension. (Married option; Unmarried standard form) The Single Life Pension option provides you with an actuarially adjusted benefit for your life. Upon your death, no further payments will be made to anyone else. If you are married, your spouse must consent to the form of payment on forms maintained by the Plan.
- Qualified and Joint Survivor Annuity: Three Options. (Married only) The Plan provides for three joint and survivor annuity options: the 50%, 75% or 100% Qualified and Joint Survivor Annuity. Depending on which of the three you elect, upon your death, your Eligible Spouse will receive either 50%, 75% or 100% of your benefit for the remainder of his or her lifetime. Because part of your pension is saved for your surviving Eligible Spouse under these options, your monthly pension benefit will be reduced to the actuarial equivalent of the Single Life Pension. Spousal consent is not required to elect any of these joint and survivor annuity options.
- Qualified and Joint Survivor Annuity with Pop-Up Feature. (Married only) A Qualified and Joint Survivor Annuity with Pop-Up Feature is the same 50%, 75% or 100% Qualified and Joint Survivor Annuity option explained above, except that if your Eligible Spouse predeceases you, you will then become eligible to receive the amount which would have been payable to you in the form of a Single Life Pension. The resulting increase would become effective at the first month following the month of your Eligible Spouse's death. In addition to the actuarial reduction described above for the Qualified and Joint Survivor Annuity options, the monthly payments under this Pop-Up option will be further reduced to reflect the additional cost of the Pop-Up Feature. Your spouse must consent to this form of payment on consent forms maintained by the Plan.
- Ten Year Period Certain. (Married or Unmarried) The Ten Year Period Certain option provides you with an actuarially adjusted monthly benefit for your life (*i.e.*, your monthly pension benefit will be reduced to the actuarial equivalent of the Single Life Pension). Also, if you die prior to receiving 120 monthly benefit payments, the Plan will continue to make payments to your designated beneficiary until a total of 120 monthly payments have been made under the Plan. If you and your designated beneficiary both die prior to receiving 120 monthly benefit payments, the Plan will continue to make payments to your designated contingent beneficiary. You must designate your beneficiary on forms maintained by the Plan, and the Trustees must receive those forms during your lifetime. If you are married, your spouse must consent to this form of payment on consent forms maintained by the Plan.

Comparison example of optional forms of payment:

The benefit shown in the Normal Pension benefit example is based on a Single Life Pension. To compare the Single Life Pension with the other benefit options that are available under this Plan, let's assume that you are age 65 and have an Eligible Spouse who is age 61. At retirement, you have an accrued monthly pension of \$1,400 under this Plan. The actual reduction in your benefit will be based on your age and your spouse's age when you retire, and according to the actuarial tables that are specified in the Plan Document. The following chart is only for example purposes.

*(If you die before receiving 120 payments, your designated beneficiary will receive any remaining payments in this amount)

How does the Plan define Eligible Spouse?

You have an Eligible Spouse if you have been married to your spouse for at least a one-year period ending on the earlier of (i) the date your pension payments are to begin, or (ii) the date of your death.

How do these forms of payment apply to benefits earned before January 1, 2013?

The forms of payment that are available for pension benefits that you earned before January 1, 2013 under your Prior Plan's rules will depend on whether you begin to receive your pension benefit payments before January 1, 2014 or after December 31, 2013. At the time you retire, you will receive information explaining the types of benefits and amounts that you can receive under each available form of payment.

If you begin receiving pension benefit payments before January 1, 2014. Effective for pension benefits that begin payment before January 1, 2014, and if your Employer is required to pay contributions to the Plan for hours you work after December 31, 2012, you can choose either:

- To have your benefits earned before 2013 paid in any form that was permitted under your Prior Plan and your benefits earned after 2012 paid in one of the forms that are permitted under this Plan; or
- To receive both your benefits earned before 2013 under your Prior Plan and your benefits earned after 2012 under this Plan in one of the optional forms permitted under this Plan.

In either case, however, you will only be able to receive your pension benefits earned after 2012 in a form permitted under this Plan. If your Employer is not required to pay contributions to this Plan for any hours

you work after December 31, 2012, you may only receive your benefits earned before 2013 paid in a form that was permitted under your Prior Plan.

If you begin receiving pension benefit payments after December 31, 2013. Effective for pension benefits that begin payment after December 31, 2013, you may only elect one of the optional forms of payment permitted under this Plan for all benefits that you earned both (i) before 2013 under your Prior Plan and (ii) after 2012 under this Plan. In other words, you may no longer choose to have your benefits earned before 2013 paid in a form permitted under your Prior Plan unless that form of payment is also available under this Plan. Additionally, benefits earned before 2013 under your Prior Plan and after 2012 under this Plan will be paid in the same form as benefits earned before 2013.

As a result, you may no longer choose any of the following optional forms of payment with respect to benefits you earned prior to January 1, 2013: if married, the 50%, 66-2/3%, 75% or 100% Joint and Survivor Annuity with Five Year Period Certain. Also, if you are married, the standard form of payment will no longer be a 100% Joint and Survivor Annuity. Instead, the standard form of payment for a married participant is 50% Qualified and Joint Survivor Annuity. If you are single at retirement, the standard form of payment will no longer be a Single Life Pension with Five Year Period Certain. Instead, the standard form of payment for an unmarried participant will be a Single Life Pension.

IMPORTANT: It is important to emphasize that this rule does not change any other provisions of this Plan or your Prior Plan. For example, the eligibility criteria for a Normal Pension or Early Pension benefit have not changed. Also, all available forms of benefit payment will continue to be actuarially adjusted to reflect their value compared to the Single Life Pension.

Application to Disability Pension. Please note that for Disability Pension applications received after December 31, 2012, and for benefits that you earned both before 2013 under your Prior Plan and after 2012 under this Plan, you will only be able to receive your Disability Pension benefit in a form permitted under this Plan. This rule applies regardless of when you begin to receive payments for your Disability Pension.

Must I begin receiving my pension payments by a certain time?

Yes. You generally must file an application for your pension benefits to commence on a date no later than your required beginning date, which is April 1st of the calendar year following the calendar year in which you attain the applicable age, determined as follows:

Participant Birthdate	Applicable Age
Prior to July 1, 1949	70-1/2
On or after July 1, 1949 but before January 1, 1951	72
On or after January 1, 1951	73

In the event that you fail to properly file an application for benefits so that benefit payments can commence on or before your required beginning date as described above, the Plan will automatically begin payment of your benefits in the form of a 50% Joint and Survivor Annuity, which is the default form of payment for purposes of this distribution. In the event that you have not identified the birth date of your spouse, the Plan will assume that your spouse is the same age as you for the purpose of the 50% Joint and Survivor Annuity. Upon proper written application after the automatic commencement of benefits in the default form, the Plan will permit you to elect a form of payment available under the Plan

and will adjust your benefit to reflect any prior payment made under the default form of payment, effective as of the annuity starting date of the default form.

What happens if the total present value of all my future pension payments is less than \$7,000?

If the total actuarial present value of all of your projected future monthly benefit payments, when valued as a single sum payment instead of monthly payments, is \$7,000 or less (\$5,000 or less before October 1, 2024) at the time you apply for benefits, you will receive a lump sum payment instead of payment under any other form. This lump sum is paid regardless of your marital status. For purposes of these rules, the actuarial present value includes your pension payments for benefits you earned both under your Prior Plan before January 1, 2013 and under this Plan after December 31, 2012.

You may elect to receive this lump sum payment:

- In a direct rollover to another qualified retirement plan or an individual retirement account (IRA);
- In a check payable to you; or
- In a combination of the above.

If you do not make an election within the time frame specified in the notice of your right to elect a direct rollover for your benefit of less than \$7,000, the Plan will make a mandatory distribution as soon as administratively feasible as follows:

- If the single sum actuarial present value of all of your future projected monthly benefit payments is \$1,000 or less, you will receive a check made payable to you.
- If the single sum actuarial present value of your future projected monthly benefit payments is over \$1,000 but less than or equal to \$7,000, your benefit will be distributed in the form of a lump sum payment in an automatic rollover to an individual retirement account (IRA) established by the Plan in your name.

When you become eligible for a distribution, the Plan Office will provide more information about your payment options, including the direct rollover rules and the federal income tax treatment regarding the lump sum payment.

What happens if I divorce my spouse after electing a form of payment?

In general, if you elected to receive a form of benefit that provides for ongoing pension payments to your surviving spouse upon your death, your spouse will remain entitled to the payments even if you divorce. However, if you divorce, the rights of your former spouse may be modified by the terms of a qualified domestic relations order, also known as a QDRO, as entered by a court and approved under the Plan's QDRO procedures. The terms of a QDRO may require certain payments to be made from your benefits for alimony, child support or the marital property rights of your spouse, former spouse, child or other dependent.

A QDRO may affect the amounts of benefits you will receive or are receiving. If you have questions about QDROs or would like to receive a copy of the Plan's QDRO procedures at no charge, please contact the Plan Office.

ABOUT SURVIVOR BENEFITS IF A PARTICIPANT DIES BEFORE RETIREMENT

What survivor benefits are payable if a Participant dies before retirement?

For benefits you may earn on or after January 1, 2013, the Plan will pay monthly benefits to your surviving spouse for life if you die before you begin to receive benefits (also called the “Surviving Spouse Death Benefit”), provided you satisfy the following criteria:

- You have at least five Years of Eligibility Service (for this purpose, Years of Eligibility Service earned both before 2013 and after 2012 will be added together); and
- You and your spouse were married throughout the 12 months immediately preceding your death.

The monthly benefit to your spouse will equal the monthly benefit you could have received from the Plan under a 100% Qualified Joint and Survivor Annuity and reduced for age (if applicable), calculated as of the first day of the month following the date of your death or, if later, the first day of the month after you would have attained your earliest retirement age. Payment to your surviving spouse will begin at such time as elected by your spouse, but not before the later of these two dates.

ABOUT PROHIBITED EMPLOYMENT

What does Prohibited Employment mean?

If you return to work after terminating employment and beginning to receive a pension benefit, or if you continue working after your Normal Retirement Date without retiring, your eligibility to receive a pension will be suspended. You will permanently forfeit the benefits that are suspended if your ongoing employment is considered “Prohibited Employment.”

Different rules generally apply to determine what type of employment is considered “Prohibited Employment” for this purpose, with respect to the portion of your pension benefit that you earned (i) before January 1, 2013 under your Prior Plan, and (ii) after December 31, 2012 under this Plan. However, the suspension rules under this Plan will apply to service earned prior to 2013 under your Prior Plan to the extent that the rules under this Plan are more liberal than the rules in effect under your Prior Plan. A separate SPD was previously provided to you that describes the suspension rules under your Prior Plan.

For the portion of your benefits earned under this Plan after December 31, 2012, Prohibited Employment means work of 40 hours or more in a month during which you receive payment for an hour of work in employment or self-employment of the type described below:

- In the same industry in which employees covered under the Plan were employed and accrued benefits under the Plan at the time benefits commenced or would have commenced if you were not engaged in Prohibited Employment; and
- In the same “trade or craft” in which you were employed at any time while covered by the Plan; and

- In any geographic area in which employees covered by the Plan were employed when payment of your Plan benefits commenced or would have commenced if you were not engaged in Prohibited Employment.

An hour of work for these purposes includes work hours and non-work hours for which you receive payment.

IMPORTANT EXCEPTION. For benefits earned both under your Prior Plan and under this Plan, you can continue to receive benefits after retiring if you return to work in a category of employment that is not covered by either (i) a Collective Bargaining Agreement (regardless of whether the work is actually performed with an Employer) or (ii) an assent of participation or other form of participation agreement between an Employer and the Board of Trustees. As of the date that this SPD was published, examples of work categories that would not result in a suspension of benefits include (but are not limited to) work as a superintendent, estimator or safety instructor, insofar as these are work categories that are not covered by a Collective Bargaining Agreement or participation agreement. On the other hand, work as a general foreman or foreman would generally not qualify for the exception because these job categories are covered by a Collective Bargaining Agreement. For benefits accrued on and after July 1, 2022, supervisory activities performed for a non-Employer (*i.e.*, an employer that does not contribute to the Plan) do not qualify for this exception.

In addition, if you perform work as a training fund instructor employed by the Indiana/Kentucky/Ohio Regional Council of Carpenters Joint Apprenticeship and Training Program or as a high school instructor, you may exceed the normal monthly limit on hours worked (40 or more hours) in Prohibited Employment by up to an aggregate total of 600 hours during a calendar year and still continue to receive monthly pension benefits.

IMPORTANT TEMPORARY EXCEPTION. Effective for the 13-month period beginning December 1, 2016, and ending December 31, 2017, and further effective for both 12-month periods beginning January 1, 2018 and ending December 31, 2018 and beginning January 1, 2019 and ending December 31, 2019 (hereinafter each referred to, in part, as an “Exception Period”), for benefits earned under your Prior Plan and under this Plan, you can continue to receive benefits after retiring if you return to Covered Employment and work for an Employer for up to 600 hours during each Exception Period. In other words, monthly employment of 40 hours or more will not be considered Prohibited Employment for purposes of the Plan’s Early and Normal Retirement Benefits if you have not yet worked in Covered Employment for an Employer in excess of 600 aggregate hours during an Exception Period. After your aggregate hours of Covered Employment reach 600 during an Exception Period, the general rule (including the suspension rule that applies if 40 or more hours of Prohibited Employment are performed in a month) will apply. Employment with a non-Employer (*i.e.*, an employer that does not participate in the Plan) which meets the definition of Prohibited Employment above will continue to be considered Prohibited Employment and is not subject to this temporary exception.

IMPORTANT TEMPORARY LIMITED EXCEPTION. Effective for the 10-month period beginning March 1, 2020 and ending December 31, 2020 (hereinafter referred to as the “Limited Exception Period”), for benefits earned under your Prior Plan and under this Plan, you can continue to receive benefits after retiring if you work for an Employer for up to 600 hours during the 2020 calendar year, provided that you (a) retired prior to March 1, 2020 and (b) return to Covered Employment within the Plan’s geographic area except for work in one of the following northwest Indiana counties: Benton, Carroll, Clinton, Jasper, Lake, LaPorte, Newton, Porter, Pulaski, Starke, Tippecanoe, Warren and White (the “Excepted Counties”). After your aggregate hours of such Covered Employment exceed 600 during the 2020 calendar year, the general rule (including the suspension rule that applies if you

perform 40 or more hours of Prohibited Employment in a month) will apply. Employment with a non-Employer (*i.e.*, an employer that does not participate in the Plan) or within the Excepted Counties that meets the definition of Prohibited Employment above will continue to be subject to the 40 hour or more Prohibited Employment rule and is not subject to this temporary limited exception.

IMPORTANT TEMPORARY EXCEPTION. A temporary exception to the Prohibited Employment rules described in this section shall apply for benefits earned under the Prior Plan (as applicable) and under this Plan, during the following periods (each referred to, in part, as an “Exception Period”): June 1, 2021 to December 31, 2021 for participants who retired prior to June 1, 2021; January 1, 2022 to December 31, 2022 for participants who retired prior to January 1, 2022; January 1, 2023 to December 31, 2023 for participants who retired prior to January 1, 2023; January 1, 2024 to December 31, 2024 for participants who retired prior to January 1, 2024; and January 1, 2025 to December 31, 2025 for participants who retired prior to January 1, 2025.

- For the Exception Periods occurring in 2021 and 2022, you may exceed the normal monthly limit on hours worked (40 or more hours) in Prohibited Employment by up to an aggregate of 600 hours during an Exception Period and continue to receive monthly pension benefits, provided that you are performing Covered Employment for an Employer.
- For the Exception Period occurring in 2023, you may exceed the normal monthly limit on hours worked (40 or more hours) in Prohibited Employment by up to an aggregate of 1,000 hours during the Exception Period and continue to receive monthly pension benefits, provided that you are performing Covered Employment for an Employer.
- For the Exception Periods occurring in 2024 and 2025, you may exceed the normal monthly limit on hours worked (40 or more hours) in Prohibited Employment by up to an aggregate of 1,200 hours during the Exception Period and continue to receive monthly pension benefits, provided that you are performing Covered Employment for an Employer.

If you exhaust the 600-hour limit, 1,000-hour limit or 1,200-hour limit, as applicable, during an Exception Period, the Plan’s general suspension of benefits rules will again apply, including suspension and forfeiture of your pension benefits if you work 40 or more hours of Prohibited Employment in a calendar month. Employment that meets the definition of Prohibited Employment (as described above) and is performed for an employer that does not contribute to the Plan continues to be subject to the monthly 40 hour or more Prohibited Employment rule and is not subject to this temporary exception. As such, such employment will continue to result in suspension and forfeiture of your monthly pension benefits.

After I begin receiving a pension can I work at some other type of job?

Yes. After you begin receiving your pension, you may work in any other kind of employment other than Prohibited Employment, and you will continue to receive your monthly pension checks as usual. If you are not sure whether or not a job you are considering will be Prohibited Employment, please contact the Plan Office.

Does my pension stop if I return to Prohibited Employment?

Yes. After you begin receiving your pension, if you return to Prohibited Employment, you will not receive a pension check for the particular months you work in that Prohibited Employment. If your benefits are suspended, you will be provided with a notice and a full description of the reasons for the suspension and the procedures for a review of the suspension and resumption of benefit payments.

Must I provide the Plan notice of my return to employment?

Yes. If you return to Prohibited Employment, you must notify the Plan Office of your return to work within 30 days of the date you return. Also, a portion of your benefit may be withheld when you resume your benefit payments, to ensure that the Plan recovers any benefits paid to you while you were working in Prohibited Employment without providing notice to the Plan. If the Board of Trustees learns that you have worked in Prohibited Employment without providing proper notice, it will be presumed that you have been working for as long as the contractor for whom you work has been engaged at the construction site. This may affect the amount of your benefit when you again retire. You will have the right to overcome this presumption by establishing the actual facts.

May I request a review of the suspension of my benefits?

Yes. You are entitled to a review of any determination suspending your benefits. You may file a written request for review with the Board of Trustees within 180 days of the notice of suspension at the address of the Plan Office. In this manner, you may also request that the Board of Trustees review any contemplated employment to determine whether it will be Prohibited Employment.

If my benefit is suspended, when will my benefit payments resume?

If your benefit is suspended, you will be provided with a Resumption of Benefits Notice, which you must return to the Plan Office as soon as you learn that you will cease the type of employment which caused your monthly pension benefits to stop. After this Notice is received at the Plan Office, your benefit will be paid for the months after the last month the benefit was suspended, although actual payment is not mandatory until the first of the third month following the last month of suspension.

What happens if I received benefits while working in Prohibited Employment?

If you received benefits during any months when you worked in Prohibited Employment, your benefit amount may be temporarily reduced for as long as it takes to recover the amount of benefits paid to you to which you were not entitled, to the extent permitted by law. Any pursuit of overpayment recovery will be made in a manner consistent with applicable law, including the SECURE 2.0 Act of 2022.

If I return to Prohibited Employment, will my benefits be recalculated when I retire again?

Yes. If you work in Prohibited Employment, you may earn additional Benefit Accrual Credit. Your pension benefit will be recalculated when you retire again to include any additional Benefit Accrual Credit you earn. If you originally retired and received a pension before your Normal Retirement Date, your recalculated pension will be actuarially adjusted to take into account the benefit payments received before your Prohibited Employment.

How will I be impacted if I continue working in a contributory position that qualifies as Prohibited Employment after my Normal Retirement Date?

Participants who stop working before their Normal Retirement Date, but who do not apply for a benefit until after their Normal Retirement Date, are entitled to all monthly benefits that could have been paid after their Normal Retirement Date had they applied sooner. In these cases, the Plan will automatically increase the monthly pension amount or offer a lump sum that equals the amount of the missed payments. However, if a Participant continues working in Prohibited Employment after his Normal Retirement Date without retiring, then that Participant is not entitled to monthly benefit payments until he actually retires. The Participant would then be entitled to a benefit based on his Benefit Accrual Credit earned on and after

his Normal Retirement Date. The Plan also includes provisions that may impact the calculation of your benefit if you continue working in Prohibited Employment after you attain age 70 ½.

Where may I find the Plan's rules regarding suspension of benefits?

The Plan's rules and regulations for suspension of benefits can be found in Article IV of the Plan Document, which is kept in the Plan Office. The suspension of benefits provisions in the Plan Document are compliant with Department of Labor regulations concerning suspension of benefits. Those regulations can be found in Section 2530.203-3 of Volume 29 of the Code of Federal Regulations.

ABOUT APPLYING FOR A BENEFIT

How can I apply for a pension?

To apply for a pension under the Plan, you should write or call to request an application from the Plan Office at:

When should I apply for a pension?

You should file a pension application within 180 days in advance of the month you want to receive your first pension check. Pensions are usually effective on the first day of the month following the month during which all conditions for the pension are met, including the filing of an application. However, because some time is required to process the applications, the first few checks may be delayed and paid retroactive to the effective date.

Must I submit proof of age with my pension application?

Yes. Instructions describing the type of acceptable proof of age will be given to you with your application. If your pension is to be paid as one of the Qualified Joint and Survivor Annuity options, you will also be asked to submit proof of your spouse's age and proof of your marriage.

Who will decide if I am eligible for a pension?

The Board of Trustees is bound by the terms of the Plan Document and will decide if you meet the eligibility requirements for a pension under the Plan Document. The Trustees are the sole judges in reviewing the documents you submit with your application, in making factual determinations and in interpreting and applying the Plan Document.

When should application for the Surviving Spouse Death Benefit be made?

A written application for payments under the Surviving Spouse Death Benefit should be submitted by the spouse to the Trustees as soon as possible following the date of death of the Employee, but no later than two years after the date of death of the Employee.

ABOUT APPEAL OF DENIAL OF BENEFITS

How will I know if my application for benefits is denied?

If your application for a benefit (other than a Disability Pension) is partially or wholly denied, you will receive written notice from the Board of Trustees within 90 days. In some cases, the decision of the Board of Trustees may be delayed due to matters beyond the control of the Plan or in order to provide you with additional time to provide necessary information. If additional time is needed to render a decision on your claim, the Plan will notify you in writing, prior to the expiration of the initial 90-day period, of the reasons for the delay and the date, no later than 180 days after the initial receipt of your claim, by which the Plan expects to render a decision on your claim.

For benefit claims other than Disability Pension claims, the written notice of denial will include:

- The specific reason for the denial;
- Specific reference to the provision or provisions of the Plan on which the decision is based;
- A copy of any internal rule, guideline, protocol, standard or other similar criteria relied upon, or a statement that a copy of such internal rule, guideline, protocol, standard or other criteria will be provided free of charge upon request;
- A description of any additional material or information required to substantiate your claim and an explanation of why it is necessary;
- A complete description of the appeal procedure and any applicable time limits to request review of your claim; and
- A statement that you have the right to bring a civil action under ERISA following an adverse benefit determination on appeal and expiration of any applicable deadlines.

If your application for a Disability Pension is partially or wholly denied, you will receive written notice from the Board of Trustees within a reasonable time of submitting your application, but not more than 45 days after the application is filed. If the Board of Trustees determines that an extension of time is necessary to make a decision about your Disability Pension application for reasons beyond the control of the Plan, you will receive a notice identifying the circumstances. The Trustees are allowed to grant two extensions of time for 30 days in each such case. You will be notified of the necessity of the extension of time before the end of the initial 45-day period if the first extension is required, and before the end of the additional 30-day period if the second extension is required.

The written notice of denial of a Disability Pension claim will include:

- The reason or reasons why your claim was denied, including a discussion of the decision and an explanation of the basis for disagreeing with or not following:
 - The views presented to the Plan of any health care professionals who treated you or vocational professionals who evaluated you;

- The views of any medical or vocational experts whose advice was obtained by the Plan in connection with your claim; or
- A disability determination made by the Social Security Administration presented to the Plan;
- Specific reference to the Plan provision(s) on which the decision is based;
- A copy of any internal rule, guideline, protocol, standard or other similar criteria relied upon, or a statement that no such internal rule, guideline, protocol, standard or other criteria exists;
- A description of any additional material or information required to substantiate your claim and an explanation of why it is necessary;
- A complete description of the appeal procedure and applicable time limits to request review of your claim;
- A statement that you are entitled to receive, upon request and free of charge, reasonable access to, and copies of, all documents, records and other information relevant to your claim; and
- A statement that you have the right to bring a civil action under ERISA following an adverse benefit determination on appeal and expiration of any applicable deadlines.

Do I have the right to appeal if my claim is denied?

Yes. If you disagree with the initial decision denying your claim, you may file a written request for a review by the Board of Trustees. You must file your appeal with the Board of Trustees within 60 days (180 days for Disability Pension applicants) of the date you receive the denial notice at the address shown below:

Your written appeal should state all the reasons why you disagree with the initial decision denying your claim. You or your representative (e.g., an attorney) may review all pertinent documents, records and other information relevant to your claim. If you do not file an appeal, the initial decision will become a final decision.

You may submit to the Board of Trustees any document or written comments which pertain to your appeal.

The Board of Trustees will make a decision regarding your appeal at its first quarterly meeting following receipt of your appeal (unless the appeal is received within 30 days of the meeting, in which case the appeal will be considered at the second scheduled quarterly meeting). If there are special circumstances requiring a delay, the decision may be made at the third quarterly meeting following receipt of your appeal. The Plan will send written notice to you if postponement is required. The Board of Trustees will advise you of their decision in writing five days after a decision has been made.

For benefit claims other than Disability Pension claims, the Board of Trustees' written decision on your appeal will:

- Contain the reason or reasons for the decision;
- Refer to specific Plan provisions on which the decision is based;
- Notify you of your right to access and copy (free of charge) all documents, records and other information relevant to the claim; and
- Notify you of the right to bring a civil action under ERISA and applicable deadlines.

For Disability Pension claims, the Board of Trustees' written decision on your appeal will:

- Contain the reason or reasons for the decision;
- Refer to specific Plan provisions on which the decision is based;
- Notify you of your right to access and copy (free of charge) all documents, records and other information relevant to the claim;
- Include a discussion of the decision and an explanation of the basis for disagreeing with or not following:
 - The views presented to the Plan of any health care professionals who treated you or vocational professionals who evaluated you;
 - The views of any medical or vocational experts whose advice was obtained by the Plan in connection with your claim; or
 - A disability determination made by the Social Security Administration presented to the Plan;
- Include a copy of any internal rule, guideline, protocol, standard or other criteria relied upon, or a statement that no such internal rule, guideline, protocol, standard or other criteria was considered; and
- Notify you of the right to bring a civil action under ERISA and applicable deadlines, including the calendar date by which you must bring a legal action against the Plan.

It is important that you comply with the Plan's appeal procedures if you disagree with the initial denial of your claim. In the event a claim for benefits has been denied, no legal action against the Plan may be brought unless the decision has been appealed in accordance with these procedures. Legal action against the Plan may not be commenced more than 180 days after the Board of Trustees notifies you of the decision on your claim on appeal.

Is the Board of Trustees' decision binding?

The decision of the Board of Trustees will be binding unless determined to be arbitrary or capricious by a court having jurisdiction over such matters. In other words, benefits will only be paid under the Plan if the Board of Trustees decides in its discretion that the applicant is entitled to benefits.

If I owe money, can I sign over rights to my pension?

No. The Plan contains a provision prohibiting any federal tax lien or transfer, assignment, sale or attachment of a pension benefit, except in relation to a QDRO, as discussed above.

Does applying for a pension from this Plan affect my Social Security rights?

No. The benefits provided by this Plan (and by your Prior Plan) are in addition to any benefits which you may receive from Social Security.

IMPORTANT FACTS ABOUT THE PLAN

The following information provides important facts about the Plan which you should know.

- (a) **Name of Plan.** This Plan is known as the Indiana/Kentucky/Ohio Regional Council of Carpenters Pension Plan.

- (i) **Collective Bargaining Agreements.** This Plan is maintained pursuant to one or more Collective Bargaining Agreements between participating Employers and the Indiana/Kentucky/Ohio Regional Council of Carpenters (or any other labor organization that becomes a party to the Trust Agreement in a manner accepted by the Trustees). A copy of any such agreement may be obtained by participants and beneficiaries upon written request to the Plan Administrator and is available for examination by participants and beneficiaries.
- (j) **Eligibility and Benefits.** The type of benefits provided and the Plan's requirements with respect to eligibility as well as circumstances that may result in disqualification, ineligibility or denial or loss of any benefits are fully described in this SPD.
- (k) **Pension Benefit Guaranty Corporation Insurance.** Your pension benefits under this multiemployer plan are insured by the Pension Benefit Guaranty Corporation ("PBGC"), a federal insurance agency. A multiemployer plan is a collectively bargained pension arrangement involving two or more unrelated employers, usually in a common industry.

Under the multiemployer plan program, the PBGC provides financial assistance through loans to plans that are insolvent. A multiemployer plan is considered insolvent if the plan is unable to pay benefits (at least equal to the PBGC's guaranteed benefit limit) when due.

FORMER LOV FUND PARTICIPANTS

The maximum benefit that the PBGC guarantees is set by law. Under the multiemployer program, the PBGC guarantee equals a participant's years of service multiplied by (1) 100% of the first \$11 of the monthly benefit accrual rate and (2) 75% of the next \$33. The PBGC's maximum guarantee limit is \$35.75 per month times a participant's years of service. For example, the maximum annual guarantee for a retiree with 30 years of service would be \$12,870.

The PBGC guarantee generally covers: (1) Normal and early retirement benefits; (2) disability benefits if you become disabled before the Plan becomes insolvent; and (3) certain benefits for your survivors.

The PBGC guarantee generally does not cover: (1) Benefits greater than the maximum guaranteed amount set by law; (2) benefit increases and new benefits based on plan provisions that have been in place for fewer than 5 years at the earlier of: (i) the date the Plan terminates or (ii) the time the Plan becomes insolvent; (3) benefits that are not vested because you have not worked long enough; (4) benefits for which you have not met all of the requirements at the time the Plan becomes insolvent; and (5) non-pension benefits; such as health insurance, life insurance, certain death benefits, vacation pay, and severance pay.

- (l) **Retroactive Changes.** The Plan will not make retroactive changes in the vesting or accrual provisions of the Plan.
- (m) **Source of Contributions.** The benefits described in this SPD are provided through employer contributions. The methods by which the amount of employer contributions are calculated are determined by the provisions of the Collective Bargaining Agreements.
- (n) **Identity of Funding Medium.** All assets are held in trust by the Board of Trustees for the purpose of providing benefits to eligible participants and defraying reasonable administrative expenses. The Pension Trust's assets and reserves are invested by professional investment managers retained by the Board of Trustees.
- (o) **Plan Year.** The records of the Plan are kept separately for each Plan Year. The Plan Year begins on July 1 and ends on June 30.
- (p) **Qualified Domestic Relations Order.** The Plan, in accordance with the law, must recognize a qualified domestic relations order ("QDRO"). A "domestic relations order" is a judgment, decree or order (including approval of a property settlement agreement) that (1) relates to the provision of child support, alimony payment or marital property rights to a spouse, former spouse, child or other dependent of a participant and (2) is made pursuant to state or tribal domestic relations law. Participants and Beneficiaries may obtain without charge a copy of the Plan procedures governing QDROs.
- (q) **Continuation of the Plan.** It is intended that the Plan will continue indefinitely and meet foreseeable situations that may occur. To protect against any unforeseen situations, however, the Trustees reserve the right to amend or terminate the Plan. If it becomes necessary to discontinue

the Plan, the assets of the Plan must be used to provide benefits according to the Plan document and Federal law. Any action to change or discontinue the Plan will be made and communicated in writing.

STATEMENT OF RIGHTS UNDER THE EMPLOYEE RETIREMENT INCOME SECURITY ACT OF 1974 (ERISA)

As a participant in the Indiana/Kentucky/Ohio Regional Council of Carpenters Pension Plan you are entitled to certain rights and protections under ERISA. The Trustees and plan administrator intend to operate the Plan fairly and to comply fully with ERISA. If you have a question about the Plan, how it is run and how it affects you, you should contact the Plan Office.

ERISA provides that all Plan participants shall be entitled to:

Receive Information About Your Plan and Benefits

Examine, without charge, at the Plan Office and at other specified locations, such as worksites and union halls, all documents governing the Plan, including insurance contracts and Collective Bargaining Agreements, and a copy of the latest annual report (Form 5500 Series) filed by the Plan with the U.S. Department of Labor and available at the Public Disclosure Room of the Employee Benefits Security Administration.

Obtain, upon written request to the plan administrator, copies of documents governing the operation of the Plan, including Collective Bargaining Agreements, and a copy of the latest annual report (Form 5500 Series) and updated summary plan description. The administrator may make a reasonable charge for the copies.

Receive a summary of the Plan's annual financial report. The plan administrator is required by law to furnish each participant with a copy of this summary annual report.

Obtain a statement telling you whether you have a right to receive a payment at normal retirement age and if so, what your benefits would be at normal retirement age if you stop working under the Plan now. If you do not have a right to a payment, the statement will tell you how many more years you have to work to get a right to a payment. This statement must be requested in writing and is not required to be given more than once every twelve (12) months. The Plan must provide the statement free of charge.

Prudent Actions by Plan Fiduciaries

In addition to creating rights for Plan participants, ERISA imposes duties upon the people who are responsible for the operation of the Plan. The people who operate the Plan, called "fiduciaries" of the Plan, have a duty to operate the Plan prudently and in the interest of you and other Plan participants and beneficiaries. No one, including your Employer, your Union, or any other person, can terminate your employment or otherwise discriminate against you in any way to prevent you from obtaining a payment or exercising your rights under ERISA.

Enforce Your Rights

If your claim for a pension benefit is denied, in whole or in part, you have a right to know why this was done, to obtain copies of documents relating to the decision without charge, and to appeal any denial, all within certain time schedules.

Under ERISA, there are steps you can take to enforce the above rights. For instance, if you request a copy of Plan documents or the latest annual report from the Plan and do not receive them within 30 days, you may file suit in a Federal court. In such a case, the court may require the plan administrator to provide the materials and pay you up to \$110 a day until you receive the materials, unless the materials were not sent because of reasons beyond the control of the administrator. If you have a claim for benefits which is denied or ignored, in whole or in part, you may file suit in a state or Federal court. In addition, if you disagree with the Plan's decision or lack thereof concerning the qualified status of a domestic relations order, and you have exhausted the Plan's claims procedure, you may file suit in Federal court (within certain time limits). If it should happen that Plan fiduciaries misuse the Plan's money, or if you are discriminated against for asserting your rights, you may seek assistance from the U.S. Department of Labor, or you may file suit in a Federal court. The court will decide who should pay court costs and legal fees. If you are successful the court may order the person you have sued to pay these costs and fees. If you lose, the court may order you to pay these costs and fees, for example, if it finds your claim is frivolous.

Assistance with Your Questions

If you have any questions about this Plan, you should contact the plan administrator.
